Motion made by Director Town to approve the agenda for June 9, 2022 Special Called Meeting. Motion seconded by Director Rohler. Motion passed by unanimous vote of Board members present. (4 -0-0)

3. OPEN FORUM / PUBLIC COMMENT: This is an opportunity for members of the public to address the Board on any subject matter within the Board's jurisdiction, but not an item on the published agenda.

- Speaker #1 Person wanted to know about the Bombay Beach Volunteer Fire Department.
- Speaker #2 Requested information on the November Election
- Speaker #3 Presented the Board with cards of gratitude from activities from the Children's Club
- Speaker #5 Requested to discuss the use of the Medical Building

4. BOARD DISCUSSION/DIRECTIVES:

- A. The Board will hear any recommended changes to the Building Use policy or schedule.
 - Positive comments from different clubs.
 - Secretary from the Woman's Club had concerns of use of building outside of the clubs allocated hours. Fitness club offered to give up some time if women's club need more time.

Recommendation and direction to secretary to provide all clubs with a list of all other clubs contact numbers in event coordination between clubs is needed.

Motion made by Director Worden to authorize secretary to have more keys made to allow each club to have key to building. Motion seconded by Director Rohler. Motion passed by unanimous vote of members present. (4-0-0)

Discussion on clubs being allowed to store some of their supplied in the Building. The secretary was directed to carry this issue to the next regular meeting.

B. Presentation by the Bombay Beach Volunteer Fire Department Proposal.

Christopher Green made a presentation to the Board. Copy of presentation is attached as Attch A

Chief Estrada announced that the County Board of Supervisors officially donated the Squad Emergency response vehicle to Bombay Beach Community Services District. Also announced was that supplies for the Community Emergency Response Training have been ordered and training will be scheduled when training supplies arrive.

Chief Estrada announced that the local Fire Department is officially under the direction of the Bombay Beach Community Services District.

Volunteers training for the Bombay Beach Volunteers could get ride along to familiarize them with responses.

Comment by Mark that the Board has no experience or ability to run a fire department and the District should allow the County to be responsible for the Fire Department. He also pointed out the liability that the Board will incur if they are at fault for actions of the volunteers.

Comment that in the 1970s there was a volunteer rescue service in Bombay Beach, and that the County should provide skeleton crews to cover Bombay Beach.

- C. District Internet The Board will discuss purchasing internet connectivity for the District Office. Item carried to next meeting.
- D. The Board will decide and initiate the process to fill a vacated Board of Director seat. – The Board will authorize the process to fill the vacated seat left by Jean Patterson.

Motion made by Director Worden to approve the process to fill the vacancy by District Board Appointment. Motion seconded by Director Burnell. Motion passed by unanimous vote of Board Members present. (4-0-0)

The secretary will make applications available and post in the local community a notice of the vacancy.

- A. The Board will discuss and provide input to the 2022-2023 Budget Development.
 - The Board will present a balanced budget of \$67,050.00 in revenues and expenses for final approval at the June 16, 2022 Regular Meeting.

- 6. <u>ADJOURNMENT:</u> Motion made by Director Worden to adjourn. Motion seconded by Director Rohler. Motion passed by unanimous vote of Board members present. (5-0-0)
