- 1. <u>CALL TO ORDER:</u> The meeting was called to order at 6:09 p. m. by Director Kattro.

2. <u>APPROVAL OF THE AGENDA</u>: The Board will approve the agenda for April 18, 2019 as is or delete/clarify any item on the agenda.

Motion made by Director Hollenbeck to approve the agenda for April 18, 2019. Motion seconded by Director Kattro. Motion passed by unanimous vote of Board members present. (5-0-0)

3. <u>APPROVAL OF THE MINUTES:</u> The Board will review and approve the meeting minutes from the last Regular Meeting on March 21, 2019.

Motion made by Director Hollenbeck to approve the meeting minutes from the March 21, 2019 Regular Meeting. Motion seconded by Director Hawkins. Motion passed by unanimous vote of Board members present. (5-0-0)

Motion to approve the financial report was made by Director Hollenbeck. Motion seconded by Director Kattro. Motion passed by unanimous vote of Board members present. (5-0-0)

5. OPEN FORUM /PUBLIC COMMENT: This is an opportunity for members of the public to address the Board on any subject matter within the Board's jurisdiction, but not an item on the agenda. Any action taken as a result of public comment shall be limited to direction to staff. (Please Limit Comments to 3 Minutes per speaker and to 30 minutes limit for open forum) (Each speaker is requested to voluntarily provide their name and residence prior to speaking)

Sonia Herbert – a local resident, wanted to know what happened to wi-fi for the District. Director Knight explained that the initial proposal from one of the cell site users was to test wi-fi for small communities. The organization that provides assistance and information for wi-fi and broadband is the Southern Border Broadband Consortium (SBBC). The District does not have a representative that attends SBBC meetings and presentations. Sonia also asked about the entrance to Bombay Beach, and why the plants were not properly watered. Director Knight responded that the water supply does not have enough pressure to feed all the plants on the street entering Bombay Beach. The plants that were planted in the past keep dying. The Secretary was directed to add as an agenda item for next meeting "Beautification of A Street.

Tao Ruspoli – a local homeowner, announced that there is a garden area at 9535 Ave H that has wi-fi available. Tao is also a Biannale (Art Festival) promoter and reported that Bombay Beach was in a write up in the New York Times.

Mark Hegadorn - a local resident, asked if a Board Member could attend the SBBC

meetings.

Robert – a local resident, asked how did the representative for the North End, representing Bombay Beach was appointed. Sonia Herbert stated that she was asked to be the representative because the deadline for appointment on that day. This is for the Advisory Committee for North End representative. The secretary was directed to contact the County CEO and the Board of Supervisors and find out why the representative selection was not made available to the local citizens.

Mark Hegadorn again asked who will go to the SBBC meetings. The Secretary was directed to contact SBBC and report on SBBC meeting information.

Herbert – a local resident, reported that there was straw blowing around on streets around 2nd and D and, 4th and D. Pat at Bucks place had many illegal parked cars.

Rhonda Hegadorn – a local resident, recommended developing a Bombay Beach Quick Reference Book that includes information that would be helpful to new local home owners. Director Knight commented that he had some information that might help her.

6. <u>OLD BUSINESS – DISCUSSON/ACTION ON THE FOLLOWING:</u>

A. <u>Bombay Beach North Properties</u> – The Board will hear a report on the progress of the refund process with individuals claiming interests in Bombay North. (Resolution 2018-06-01 ends June 21, 2019)

A request for refund was received from Mr. Richard F. Bringle for his claim as investor #9 — Original investor was Richard Bringle per receipt #6020 dated 11/15/1981. A claim for reimbursement has been received from Richard F. Bringle. The claimant has provided documentation, a copy of the original receipt #6020 and a copy of his Arizona Drivers License, that shows he is Richard F. Bringle. No assignment of interest were found in the District files.

Motion made by Director Hollenbeck to approve the claim of \$1,000.00 submitted by Richard F. Bringle. Motion seconded by Director Knight. Motion passed by unanimous vote of Board. (5-0-0)

The Secretary was directed to issue a Cashiers Check from the Bombay North savings account, to Richard F. Bringle at his address listed on his drivers license.

B. Flood Control in Bombay Beach residential area. –The Board will be updated on the progress of the District effort to provide flood protection for Bombay Beach. (Item introduced 11/19/2015) Director Knight requested that this agenda item be renamed, Maintenance of 5th Street Berm. He reported that in order to go forward with putting large pipes under the berm, the job will need to opened up to contractors. The project would require having a pump that would push the water out to the sea. The estimated costs would run approximately \$30,000 for studies

and EPA clearances and another \$5 to 10 thousand for County permits. The project would only be completed by licensed contractors that are approved by the County. Director Hawkins requested that Director Knight provide a report to the Board that explained what needed to be done.

Sonia Herbert wanted to make a comment but was halted by the Board Chair recalling that she had threatened a lawsuit on the Board regarding this subject, and she has not rescinded her threat of lawsuit.

C. <u>Update on Neighborhood Watch Program</u> - Director Hollenbeck reported that the public program that allowed blotters to be viewed was no longer available.

The next Neighborhood Watch Meeting will be on May 25, 2019 at 10:30 a.m.

The Board directed the secretary to move this item to Community Reports.

D. Street Lights – The Board will hear on the progress of improved street lighting on Bombay Beach. Particularly for lighting streets that are used by the school bus. (Item introduced February 15, 2018, Kattro).

Director Kattro reported that he had tested a light fixture on 3rd and H Street. He also reported that he has received permission from Zito Media to install solar lights on post on 3rd Street at the crossing of B, D, F and H Avenues. Director Knight said lights need to be on an arm and not installed directly on the poles. A volunteer from the public said she would help install the solar lights. Director Knight insisted that anyone working on those lights be bonded and licensed. Another person volunteered to help install the solar lights, and he was bonded and licensed. Director Kattro will report progress at next meeting.

- E. <u>Disposition of excess equipment</u> Discuss the disposition of the blue water pump that is owned by the District. (introduced January 2018, Hawkins). (Item tabled December 20, 2018)
- F. <u>It is recommended that the Board adopt CSDA Policies based on CSDA templates and Establish Policies based on CSDA guidelines, and establish procedures to carry out the Board Policies.</u>

All Directors have completed their review of the CSDA policy templates. The secretary will collect all recommendations from Directors and compile the first draft of the Bombay Beach policy manual. Estimated first presentation will be after the Summer break, around the October 2019 meeting.

G. Update on how the District can utilize CSDA Legal services for the required Sexual Harassment Training or request the Districts Legal to provide the training. Response from the Districts Legal has not been received regarding the cost to conduct sexual harassment training. The cost to conduct a CSDA on demand

presentation will cost \$55.00 per attendee, 8 attendees, total cost \$440.00.

Motion made by Director Hawkins to approve the cost for CSDA on demand training. Motion seconded by Director Knight. Motion passed by unanimous vote of the Board members present. (5-0-0)

The Board directed the secretary to order the CSDA on demand training and to set up a special meeting to accommodate the sexual harassment training. The Board selected Saturday, May 25, 2019 at 11:00 A.M. for the special meeting.

H. County Roads Department - The Board will hear the results of the request to the County Roads Department on the repair of the public streets on Bombay Beach. (Knight)

Director Hollenbeck reported that she attended the County SB 1 meeting and found that Bombay Beach was not on the list of communities where street repair was scheduled. The secretary was directed to invite Public Works Director John Gay to the next meeting in May to provide information on how can Bombay streets be given attention.

- I. Process to put an Ordinance on the next Ballot to pay for street lighting (Hawkins Tabled 3/21/2019)
- J. The Board will hear an update on bringing Trash Collection bins to Bombay Beach. (Knight)

Tao Ruspoli provided a Trash Collection plan for the Board. The plan requires the Board to establish a contract for trash container placement and trash pick-up with Republic Waste Management to place trash container bins at 2913 2nd Street.

Motion made by Director Kattro to authorize Director Louis Knight, to establish a contract for trash container placement and trash pick-up with Republic Waste Management. Motion seconded by Director Hollenbeck. Motion passed by unanimous vote of the Board members present. (5-0-0)

K. The Board will consider establishing an Ad Hoc committee to address Community concern to the Sheriffs' Office. (tabled 3/21/2019)
