9. <u>OPEN FORUM /PUBLIC COMMENT:</u> This is an opportunity for members of the public to address the Board on any subject matter within the Board's jurisdiction, but not an item on the Agenda announced in the published agenda, only those public comments electronically received by the secretary will be presented to the Board.

The Board allowed public comment in an outdoor meeting.

Sonia Herbert, Bombay Beach resident, spoke in favor of the art community and how they have been instrumental in bringing world wide attention and travelers to Bombay Beach. She accused the Board of being biased towards the art community and the Board needs to look more favorably to the art community.

Herb, Bombay Beach resident, asked when will the streets on Bombay Beach be fixed. Director Knight responded that it may be a couple of years before the County gets to

Bombay Beach street update. Director Knight stated that the streets have not been repaired since around 1961 - 1962.

Richard Morse, Bombay Beach resident, commented that there are some people that love or hate the art community. The art community have brought world attention to Bombay Beach. Director Knight commented that the art visitors were trashing the town. They had a party last week and the art people were not respecting the community.

#### 10. <u>OLD BUSINESS – DISCUSSON/ACTION ON THE FOLLOWING:</u>

A. <u>Bombay Beach Community Services District (BBCSD) Policies based on CSDA templates and Establish Policies based on CSDA guidelines, and establish procedures to carry out the Board Policies.</u> The Board will take action on the first reading of the new District Policy Manual.

- B. County Roads Department The Board will hear an update on the results of the request to the County Roads Department for the repair of the public streets on Bombay Beach. (Knight) As stated in public comment: that it may be a couple of years before the County gets to Bombay Beach street update. Director Knight stated that the streets have not been repaired since around 1961 1962.
- C. <u>Beautification of A Street</u> The Board will discuss ideas and inputs from the public on how to beautify A Street. (Introduced May 16, 2019) (Committee to beautify A Street)

Director Knight wanted to start a plan-a-tree project for Bombay Beach. He recommends planting mesquite trees because they are less maintenance and are more apt to survive the hot summers of Bombay Beach.

Discussion came up on cleaning up the District Park. There is an issue with worker liability. Director Worden recommended that District employees that are covered under workers compensation be given opportunity to work at the park. The secretary was directed to contact the workers compensation insurance company to get guidance on who could be covered to work to clean up the park.

D. Southern Border Broadband Consortium (SBBC). The Board will receive information on the viability of having a District Board Member attend SBBC meetings to enhance the possibility of bringing Broadband to Bombay Beach (Burnell)

In discussion, Directors have not completed mandatory training. The deadline for compliance is December 31, 2020. The secretary was directed to re send the link so Directors can complete training.

F. The Board will discuss the ongoing communications with AT&T about the cell tower. (Knight)

Director Knight reported that AT&T wanted to reduce their payments on Tower rental. The AT&T representative was told that the Board would not consider any reduction of tower rental payments.

G. The Board will Act on approving a resolution changing Bombay Beach
Community Services District election cycle from odd to even year elections of
governing body members. The Resolution will change the election cycle from odd
years to even years. The elections will be held on the same day as the statewide
general election. This is normally done by extending all Board members term by
one year. Approval of this resolution will result in extending all Directors term of
service for one year.
